# **DIRECTIONS FOR APPLICATION**

- · Use PRE-VAIL to inoculate only the legume(s) designated on this package.
- · Use before the expiration date marked on the package.
- · Label seed with the same expiration date if intended for resale.

### DRY APPLICATION

- · PRE-VAIL should be applied to dry, clean seed.
- PRE-VAIL will adhere to the seed naturally, therefore, do not use water to wet the seed or use any sticking agents or adhesives.
- $\cdot$  Apply inoculant at a rate of 8 oz. (227 g) per 60 lbs. (27 kg) of seed.
- $\cdot$  Allow PRE-VAIL to thoroughly mix with seed; treated seed should appear white.

# **COATING APPLICATION**

- $\cdot$  PRE-VAIL can be used as a pre-inoculant in seed coating or build-up process.
- $\cdot$  It is important to allow the seed coat to be permeable by oxygen.

Use this product before the expiration date; label seed with the same expiration date if pre-inoculated seed or coated seed is for re-sale.

### RE-INOCULATION OF PREVIOUSLY INOCULATED SEED

- · Slowly screen seed to shake off excess inoculant material.
- $\cdot$  Re-Inoculate with PRE-VAIL, following the recommended application rates and expiration dating.

## **INOCULATION OF SEED MIXTURES**

- Inoculate each legume seed component of the mixture separately using the appropriate rhizobial strain for each legume.
- $\cdot \ Blend \ the \ pre-inoculated \ components \ together \ into \ final \ seed \ mixture \ for \ bagging.$
- · Label the seed bag tags with the expiration date of the inoculant which expires first.

#### SEED TREATMENT COMPATIBILITY

- $\cdot\,\text{PRE-VAIL}$  is compatible with most fungicide seed treatments when applied dry.
- · Contact customer service at 800-350-4789 for a complete list of compatible fungicides.
- · Seed treated with this product should be stored under the same conditions.
- · Seed inoculated with PRE-VAIL only or with PRE-VAIL and metalaxyl/ mefenoxam has the same expiration date as the product itself.
- · Seed treated with PRE-VAIL and thiram has an expiration date of up to 9 months.
- · Seed treated with other fungicides/insecticides has an expiration date of up to 6 months.
- In no case can the expiration date on treated seed exceed the expiration date stated on the product container.

#### STORAGE/DISPOSAL RECOMMENDATIONS

- · Store in a cool, dry place out of direct sunlight.
- · Keep from freezing.
- · Store between 40°F and 77°F (4.4°C and 25°C).
- · Open package only when ready for use.
- · Use before expiration date.
- · Do not allow product or packaging to become wet, or exposed to high humidity.
- · Do not store product in an area to be fumigated.
- · Small amounts of product which cannot be used according to the label instruction may be disposed of in a landfill.
