GENERAL INFORMATION

microSync IronClad IDC is a granular fertilizer designed to supply increased available iron to crops. The focus crop for IronClad IDC is soybeans grown in areas with high pH and a history of iron deficiency chlorosis (IDC). Additional crops grown under high pH conditions may benefit from applications of microSync IronClad IDC.

RECOMMENDATION FOR USE IN SOYBEANS

microSync IronClad IDC is recommended to be part of a complete management program for reducing IDC in soybeans. microSync IronClad IDC is recommended as an in-furrow, soil applied fertilizer in soybeans. Broadcast applications of microSync IronClad IDC in soybeans is not recommended.

Application for IDC: 10-15 lbs/A of microSync IronClad IDC have shown to be the most effective application rate to reduce or correct IDC. Blending with other fertilizers is not recommended as other fertilizers may induce IDC.

Application in the Absence of IDC: 5-15 lbs/A of microSync IronClad IDC either alone or blended with other fertilizers. Fertilizer rates and blends should be

DIRECTIONS FOR USE APPLICATION EQUIPMENT REQUIREMENTS (IN-FURROW)

1. Always be sure to calibrate equipment before each use. Follow the calibration instructions supplied by the equipment manufacturer when using microSync IronClad IDC. Contact your equipment dealer if further assistance is needed.
2. microSync IronClad IDC must be applied using the following granular application equipment: a) Dedicated air seed tank b) Bulk granular applicator c) Hoe-drill or press-drill units. microSync IronClad IDC may NOT be applied through granular insecticide boxes or standard grain drills.
3. Be sure to clean tank/hopper, feed line, rotor, and calibration system thoroughly before filling with microSync IronClad IDC.

GENERAL RECOMMENDATION FOR USE IN OTHER CROPS

In-Furrow, Banded or Broadcast Application: Apply 5-15 lbs/A of microSync IronClad IDC either alone or blended with other fertilizers. Fertilizer application type, rate and blends should be determined based on a soil test or previous experience with the crop and field. If the field has a history of iron deficiency an in-furrow application is recommended.

Note: Multiple variables affect the rate of application necessary to control or correct IDC. Environmental factors will influence the effectiveness of treatments/applications. For best results, follow good agronomic practices, soil test, use tissue analysis and consult with a regional agronomist when using this product.
